Art. 2.b Condition of the car

The Fiat 500 Oldtimer is in good condition, no visual signs of abnormal use, no scratches nor damages.

Art. 3 Conditions/transfer/ sub-rental

At signing of the contract, the customer provides a copy of his valid driver's license, id card or passport. Our cars require a driver's license type B, or an in Belgium accepted equivalent foreign license.

Our hire conditions are only valid in the Benelux countries.

The minimum age of the customer/driver for a Fiat 500 Old timer is 23 years. If the customer/driver is younger, a supplementary deposit of 1500,00 Euro has to be provided (= franchise insurance)

The driver has to be used to driving a MANUAL car, occasional driving experience with manual cars can be not enough to handle our vintage cars; we reserve the right to refuse to let the car in case the driver is not sufficiently expert to drive a manual car, and there will be no refund.

The customer may not transfer or sub-rent the car without written approval of the Owners.

The customer refrains from using the car for illegal purposes.

Art.4 start and ending of the agreement

Art. 5 a rental tariff

For the full rental period, the customer pays the owner the sum ofEuro.

The rental price per ½ day / day is.....Euro per car.

This amount is due on signing of the agreement and in any case before the start of the rental period.

Rates include :

- ° Insurance to third parties (W.A.M. 21/11/1989)
- ° unlimited mileage
- ° taxes and VAT

Prices do not include :

- ° Costs for repairs on the body, engine and mechanic of the car, caused by misuse of the customer.
- ° Costs caused by inadequate use (such as driving off road...) or deliberate damage.
- ° Insurance of personal belongings of the customer.
- ° Total or partial fire damage caused to Vintage Tours 500 cars.
- ° Anything else not specified in the “Rates Include”.

Our rates are inclusive of VAT. Reservation is only valid upon receipt of 50% advance payment of the total rental rate. Failing to pay this advance gives the right to “Vintage Tours 500” to rent the car to another customer, without the right of the customer for any refund.

G.C.V. Vintage Tours 500 accepts credit cards.

Art. 5 b Deposit

The customer gives the Owner a deposit of Euro 500,00 at the start of the rental period.

This deposit will be fully refunded at the end of the rental period, as far as no damages are caused, as described in art. 7

Artikel 6 cancellation

Cancellation gives no right to any refund.

Art. 7 Maintenance, damage, break-down and theft.

The customer uses and maintains the car “ as a good house father”.

The customer only uses the car for the purposes described in this agreement.

The customer is responsible for the damages he causes to the rented car (missing spare parts, damages caused by third parties, theft of car items...). His responsibility cannot be higher than the agreed value of the car, as specified in the agreement. In case the customer does not return the car, he will refund the owner the value of the car as specified in art. 2a.

To cover the expenses to replace the car, this amount will be raised by 10% excl. taxes and legal interests as per tariff, starting the day the customer is put in default.

In case the customer returns the car in a dirty or bad maintained condition (not due to a normal use),which requires special cleaning, the customer will be liable for the costs.

Art. 8 – Speed – Tolerance-non smoking

The maximum speed is 60 km/hr.

“Zero tolerance” for alcohol and drugs.

It is not allowed to smoke in the car.

Art. 9 Liability

The customer declares to been given all relevant information, and declares to be able to handle the car in a correct and careful way. If needed he is responsible to ask for any further information he requires.

He also declares to have the authority, agreement, jurisdiction and lawful abilities to handle and use the rented car.

During the rental period he is the sole keeper of the car, and he engages himself to an efficient and exclusive control on the car.

The customer is responsible for any traffic fines he might cause.

The customer relieves “ GCV VINTAGE TOURS 500 “ from any responsibility and/or refund in case of technical break down, and for all costs and consequences, including body injuries, etc. caused by any break down and/or accident which might occur, whatever the cause is of the accident and/or break down is. The “ GCV VINTAGE TOURS 500” is not responsible for damage or breakdown due to weather conditions or frost. Any refund by the owners is excluded.

Consequently, the owner does not accept any liability for the rented car, especially for the misuse, abuse, uncareful use or illegal use.

Art. 10 Court

In case of dispute, the only competent court is the court of Brugge .
